### **Dean's Report-Tonya Peeples**

• Tonya reported on an October 14<sup>th</sup> meeting between the engineering management committee which included department heads and university leadership to discuss status. Discussions included consideration of the differences between debt, deficit, and underfunding. Tonya explained there is now a pathway forward in spending start-up money.

### **Associate Deans' Report**

- Shelley Stoffels informed us that award nominations are coming up.
- **Eric Donnell** informed us that EFFORT Certification needed for research grants is due 10/31. College Committee for Graduate Education met. Tonya brought up that EFC should consider designating someone to attend these types of meetings especially if there are potential changes that may affect faculty.
- Rob Rabb informed us FYS classes should consider inviting speakers on behalf of Suicide Prevention Month. Rob also spoke on Enrique's behalf. A discussion followed on student credit hours observing that 46% of hours are contained within the CoE. If that number is to increase, one viable pathway is to ensure adequate tech electives for students to choose from. A mention of the 25% of math and science credit hours taken by engineering students. Third-year retention was discussed as many discipline faculty do not engage with

students until the third year. The transfer process and NSO was also discussed within the retention context.
